# Key Transition Updates-July 2023

- VAHBE Operational Readiness Reviews (ORRs) with CMS were successfully completed in early July. ORRs involved:
  - Executing specific test cases to produce expected results when a consumer applies for health and dental insurance coverage on the Exchange.
  - End-to-end testing of account transfers to demonstrate effective transition of receiving/sending Medicaid account transfers from the FFE to the Exchange.
- On July 13<sup>th</sup> CMS granted VAHBE the Authority to Connect (ATC) to the CMS Federal Data Services Hub.
- Policy-Based Payments (PBP) work with CMS has been initiated which includes the submission of the carrier workbooks validation of APTC data.
- VAHBE is in the process of finalizing Exchange website content.
  - Content will be in English and Spanish.
  - Interpreter services will be provided via the Exchange Consumer Assistance Center.

# Agent and Assister Training and Certification Updates

- Registration for Plan Year 2024 training will open on July 28<sup>th</sup>.
- HBE will extend invitations to licensed Virginia agents, and agencies, and Virginia associations to register for training, and provide instructions.
- Training modules are expected to go live August 11<sup>th</sup>.
- HBE will utilize the Meridian Learning Management System (LMS) to offer agent, navigator, and assister training:
  - -Users can log into their accounts 24/7 and can complete training at their own pace
  - -Training will be free of charge
  - -Agents with active PY23 certifications will be able to take a limited renewal curriculum
  - -Agents must complete training and pass the exam with 80% or better for certification
- Training should be completed by October 10<sup>th</sup> for November 1<sup>st</sup> Exchange Certification
  - -The Exchange cannot guarantee certification by November 1<sup>st</sup> for Agents not able to meet the October 10<sup>th</sup> training completion deadline

# Training and Certification, continued...

- Agents will continue to be required to be licensed and in good standing through the VA Bureau of Insurance and will be required to sign a Virginia-specific agent agreement.
- Updates to requirements will be published on HBE's website, and communicated in Monthly Town Halls and via weekly email updates.



# Transition Marketing Campaigns

**Medicaid Unwinding**: Messaging to support affected individuals will be ongoing through July 2024

**Brand Awareness Campaign**: Create awareness about the transition from HealthCare.gov to Virginia's Insurance Marketplace; beginning approximately Sept. 1st

**Open Enrollment Campaign**: Drive audiences to the Marketplace's website to buy insurance; Nov. 1st to Jan. 15st

# Policy Updates

#### **Deferred Action for Childhood Arrivals (DACA)**

- On April 26, 2023, a new federal proposed rule would allow for DACA recipients to:
  - -Purchase plans and receive income-based subsidies on healthcare exchanges
  - -Participate in Medicaid or CHIP coverage for children and/or people who are pregnant in many states
- Federal Public comment period closed on June 23, 2023.
- The final rule is planned to take effect on November 1, 2023, to coincide with the Open Enrollment Period pending CMS notice.
