### HBE Response to Committee Recommendations

• Responses to the Advisory Committee's October 27, 2022 recommendations have been submitted.

## Contract Award

- After a robust 6-month evaluation and negotiation process, the multi-agency evaluation committee made a unanimous selection of the contractor for Virginia's platform and customer assistance center.
- On September 29, 2022, the State Corporation Commission awarded a nine-year contract to GetInsured - an industry leader in Exchange technology operating in 7 of the 18 state-based Exchanges nationwide.
- Since 2019, GetInsured has successfully transitioned three states from the federally facilitated marketplace to their own state-based platforms (Nevada, Pennsylvania, and New Jersey).
- Implementation activities for the new solution began on October 1 and are well underway.

## Virginia's Platform

- Leveraging proven technology from an experienced vendor
- Serves as the foundation for a health insurance marketplace that is operated in Virginia for Virginians.
- Paired with a consumer assistance center that leverages the same technology as our platform and staffed by customer service representatives dedicated to Virginia.

# Staffing Updates

- The Virginia Health Benefit Exchange is now a staff of 12. Since September 2022, HBE has hired:
  - Deputy Director for Organizational Change and Program Governance
  - Outreach and Education Manager
  - Call Center Manager
  - Finance Manager
  - Financial Analysts
- Active recruitments for a Certification & Compliance Manager, Quality Assurance Analysts, and other program coordination and business process support.
- Beginning in Q1 of 2023, we will begin recruiting for positions in the areas of Appeals, Training and Certification, Consumer Service, and Stakeholder Engagement.

## Stakeholder Engagement

- Meeting with carriers, agents and brokers, and state agency partners.
- Formal kick-offs for stakeholder townhall meetings begin January 2023.
- Engagement with stakeholders will include regular monthly meetings with VAHBE and email updates in between.

# Timeline to Launch

September 28, 2022	Official vendor contract start date.
Fall 2022	Begin Design & Development of Platform and Call Center Implementation Continue Medicaid Coordination with three work groups: Eligibility and Enrollment, Customer Service Call Center, and Data Transfer and Verifications.
Spring 2023	Systems integration testing Account Transfer testing
Spring/Summer 2023	Plan loaded and import Healthcare.gov consumer data.
Summer 2023	Training for carriers and assisters (agents and brokers, navigators, and other assisters).
Early Fall 2023	Soft launch & plan preview.
November 1, 2023-January 15, 2024	Enroll at Virginia Health Benefit Exchange.

- Leverage navigators and community-based non-profits to engage hard to reach populations. 27 inperson enrollment assistance events, 4 online events, statewide (Hampton Roads, NoVA, Central VA, Southwest VA)

## Federal and State Policy Update


- Section 1557 Proposed Rule
- Family Glitch Rule Finalized- On October 13, 2022, the IRS published the <u>Affordability of Employer Coverage for Family Members of Employees</u> final rule, to be in effect for Plan Year 2023.
- End of Public Health Emergency- now extended to at least April 2023
