



## Insights from Other States

- 18 State-Based Marketplaces (SBMs) and 3 SBM-FPs (SBM on the Federal Platform).
- Focus on core requirements in first year
- On-going engagement of key partners
- Ensure sufficient time for testing and adjustments
- Opportune timing for Virginia
  - Technology continues to mature
  - Eligible vendors have successfully transitioned and operated in several states
  - Virginia is the only state transitioning in 2022

## State Policy Update


- Reinsurance- Virginia's 1332 <u>waiver application</u> was approved on May 18<sup>th</sup>. For FY 2023, it is expected that the Reinsurance program will achieve an approximately 15.6% rate reduction relative to having no reinsurance program.
- Essential Health Benefits Benchmark Plan Study-Pursuant to <u>Item 493 D1-2</u>, BOI has begun its study of to evaluate the Commonwealth's options for potential new EHB benchmark plan. A report is due to the House Appropriations and Senate Finance Committee and the Health Insurance Reform Commission on November 1, 2022. HBE is participating in conversations.

## Recent Federal Activity

- **ARPA Subsidies-** Under current law, enhanced federal subsidies available under the American Rescue Plan will expire at the end of 2022.
  - Continued discussion at the federal level about extending the enhanced subsidies.
  - HBE continues to engage with other states to monitor federal activity and identify options for consumer education should the subsidies be ended or extended.
- **Closing the Family Glitch-** On April 5<sup>th</sup>, the Treasury Department and the Internal Revenue Service proposed a federal regulation to fix the "family glitch", including a 60-day public comment period, which ended June 6<sup>th</sup>.
  - The proposal would amend existing federal tax credit regulations to provide that the definition of affordability of employer coverage for family members of an employee is based on the employees share of the cost for whole family coverage, not that of only the employee.
  - The IRS has scheduled a public hearing for June 27<sup>th</sup>. For further detail:
